President's Report

hope all of you had great summer. I had a good vacation with my family. One highlight was the National Convention. We all gathered in Las Vegas in mid August to take care of the unions business.

As I entered the convention center on the first day session I was in awe over the sight of letter carriers as far as you could see. In fact, the convention had a record attendance of over nine thousand delegates from across the nation. I met so many interesting brothers and sisters. It was easy to start conversations with anyone because we all were there for the common cause.

Some of the highlights of the convention were Brother Dale Hart, our current Business agent, will be mov-

ing to Washington D.C. as the Director of City Delivery. Manny Peralta, our current RAA, will now be our business agent. I congratulate both of them for their accomplishments and many years of service and sacrifice for union members. These positions are well deserved.

Another major change came out of this convention. The state associations will now almost be fully responsible for organizing and training all the political activists within their respective states. Our state association currently does this but in other states it wasn't happening. National will now foot the bill for most other training the states would normally do. I commend our state president John Beaumont and his


officers for providing excellent training for political activists in California, setting the example for other states.

On the home front I am buried in grievances! We currently have about 200 of them on the GATS (Grievance Arbitration Tracking System) report waiting to be settled. Most of then are Article 8s operational window cases. Let me explain something.

We have a postmaster or OIC in every post office making \$100,000 plus in some cases and they do not have the authority to make a decision! Both of our postmasters agree they should pay the grievances but they were told they can't settle them. They can't adjust a F\$#\$&@G route on there own. I don't even think they can take a CRAP without getting permission from the District manager. They might as well carry a route and just let district run their office!

They tell me, "Well, you are told what to grieve from national." WRONG! We have the authority to grieve, settle, or do what ever in the best interest of our members. A few days ago I told our OIC that we currently have 4 or 5 204bs running this office. I made a suggestion that they could supervise in the morning and hump a route in the afternoon and I will not grieve it. That is approximately 16 hours of street assistance before you mandatory. The other staff can help with their duties in the afternoon. Why should all the extra burdens of mandatory solely be pushed on the carriers?

ere are a few short takes from the 2006 National Convention. By this time you have probably read the complete coverage from the convention in The Postal Record, so I will not rehash it here. I will say that the convention ran very smoothly, the classes before and after each session were informative even if overcrowded, and the debates on the convention were lively. There are a couple of items that pertain to Branch 1439 members specifically.

First, at the convention the branch received a compact disk produced by NALC Headquarters that deals entirely with retirement and retirement issues. If you are getting close to retirement please feel free to contact me using the information listed on Page 2. This disk has a wealth of information and will help you in planning and filling out retirement paperwork, as well as learning about the differences in retiring if your are covered under CSRS or FERS. I have distributed a number of these disks at the Ontario Main Office and Downtown Station, and I will make the same offer to those members working at Rancho and Plaza.

Next, at the convention in one of the classes the idea of Delivery Point Sequencing of flats was discussed. While DPS Flats (or FSS Flats as the USPS calls it) appears to be a ways off, there is a great article online from Sister Roberta Clemmer. Sister Clemmer works in the Carmel, Indiana post

NALC President Bill Young had each local branch president appoint a coordinator, qualifications are giving to the COLCPE fund and individuals which show a strong political interest. I was appointed by our local branch president Robert Ortiz.

Our main function other than the political functions are to get each local branch member to contribute to COLCPE mainly with automatic deductions through your bank account or through your bi-weekly paycheck, I am working closely with our branch president and branch secretary to put in place our COLCPE needs and goals for our local branch, but we need your help too!

A-Current or retirees are always welcome to contribute. We even accept one time contributions.
